A calculation of earnings and profits was completed using the most recent financial information available. Current year earnings and profits are expected to be negative for 2013. As a result, 100% of the 2013 distributions are in excess of earnings and profits.

In the event a distribution to shareholders exceeds corporate earnings and profits, as determined under IRC §312, shareholders must apply the rules of IRC §301 to determine if the distribution is a non-taxable return of basis under IRC §301(c)(2) or if the distribution is reported as capital gain under IRC §301(c)(3).
